**COACH HOUSE SKI HIRE – CONDITIONS OF HIRE AGREEMENT**

The hirer hereby hires from Coach House Ski Hire for the period mentioned the goods and equipment noted and recorded at the time of hire **SUBJECT TO THE FOLLOWING CONDITIONS.**

1. The hirer shall be responsible for the return of the goods and equipment in good order and condition.
2. The hirer will be responsible for damage, if caused through neglect or irresponsible act, to the goods and equipment
3. The hirer agrees to return the goods and equipment to the Coach House ski hire no later than 7pm on the last day of the hiring period failing which the hirer shall be liable to Coach House Ski Hire for the following and subsequent days hire at daily rates.
4. Coach House Ski Hire adheres to international DIN settings in all ski hire. Release setting numbers recorded at the time of hire correspond with the number appearing in the visual indicator windows of the bindings supplied as part of the goods and equipment. The hirer agrees not to alter the settings of these bindings under any circumstances and agrees that if they do so is in breach of the agreement, then such actions and any resultant injury, loss or damage are at the hirers own risk.
5. The ski/boot binding system is set to international DIN standard however the hirer acknowledges that this is still **NO GUARANTEE** for safety in all situations.
6. All snowboard hire is carried out with the knowledge that bindings are **NON RELEASE**.
7. The hirer acknowledges that skiing and snowboarding are sports with inherent risk of injury, save for the warranties implied by the trade practices act, hereby release and indemnify Coach House Ski Hire and its employees from any loss, injury, damage or accident however caused.
8. The hirer shall indemnify Coach House Ski Hire from and against liability in respect of claims arising directly or indirectly out of any loss, damage or injury, caused directly or indirectly out of the use of any equipment whilst under hire, which indemnity shall extend to and include all costs and expenses incurred by Coach House Ski Hire in respect of any claim therefore made upon it of investigating and/or defending the same.
9. The hirer agrees not to dry boots in any form of oven or leave directly in front of heaters. Any breach of this term will constitute damage as referred to in Clause 2. Suitable drying rooms are available at Coach House and other properties used for drying purposes.
10. **NO REFUNDS** are made on equipment returned early
